

Business Model revision for New Qualifications and renewals

Business Model Revision

Qualifications will be fairer with the new pricing policy:

- A qualification certificate will only cover Standard Number to a single technical specification; multiple technical specification certificates will no longer be issued.
- A New certificate will be charged 1,000 € + 100 € per Standard Number.
- A certificate renewal will be charged 500 € + 100 € per Standard Number.
- A charge of 500 € will be levied as registration fee for a new manufacturer, not already registered in the ASD-CERT database.
- An ACP008- Form 8 for the Manufacturing route change will be charged 500 €.

Examples for the Mechanical domain:

For a new certificate, a Manufacturer wishes to qualify the Standard Number EN 3294-050, -060, -100 with the Technical Specification EN 2582 and the Standard Number EN 3713-120 with the Technical Specification ISO 5858.

Following the new pricing policy, ASD-CERT has new certificates with 2 technical specifications (EN 2582 and ISO 5858) and 2 Standard Numbers (EN 3294 and EN 3713).

Total invoiced = $(1000 \text{ €} \times 2) + (100 \text{ €} \times 2) = 2200 \text{ €}$

Note For a new Manufacturer, ASD-CERT adds 500 euros to the total.

For a renewal of an existing PQ with the same conditions:

Total invoiced = $(500 \text{ €} \times 2) + (100 \text{ €} \times 2) = 1200 \text{ €}$

Examples for the Electrical domain:

For a new certificate, a Manufacturer wishes to qualify the Standard Number EN 2997-002, -005, -006 with the Technical Specification EN 2997-001 and the Standard Number EN 3646-005 with the Technical Specification EN 3646-001.

Following the new pricing policy ASD-CERT has new certificates with 2 technical specifications (EN 2997-001 and EN 3646-001) and 2 Standard Numbers (EN 2997-XXX and EN 3646-XXX).

Total invoiced = $(1000 \text{ €} \times 2) + (100 \text{ €} \times 2) = 2200 \text{ €}$

Note For a new Manufacturer, ASD-CERT adds 500 € to the total.

For a renewal of an existing PQ with the same conditions:

Total invoiced = $(500 \text{ €} \times 2) + (100 \text{ €} \times 2) = 1200 \text{ €}$

This new pricing policy is applied for any request since July, 1st 2011.
